Hello! I'd like to introduce myself to all of our volunteers, supporters, and members. My name is Laura Anderson and it is my great honor to serve as the newly elected President of the Board of Directors of the Las Vegas Valley Humane Society.

I am the little girl whose mother always told her, "When you grow up and have a place of your own, you can have as many animals as you want." Always wanting to give help to all of the neighborhood strays and animals who needed it, I grew up to learn about the importance of rescue and spaying and neutering our pets. I moved to Las Vegas from

the East Coast in 1998 for a job with the Clark County School District and began my volunteer career with the Las Vegas Valley Humane Society in 2001. On my first day I was thrown right in as a cat adoption counselor. From there I quickly became involved in feeding and trapping feral cats and fostering cats and kittens. As I gained experience I became a foster to special needs cats, including cats with behavioral issues, brain injuries, and vision impairments. A longtime cat lover, I soon broadened my horizons to include dog fostering and rescues. Other duties that I have filled as a volunteer include: tabling events, bake sales (looking for some amazing vegan baked goods? I'm your girl!), spay/neuter clinic volunteer, office volunteer, attending community and commission meetings, and secretary of the Board of Directors. I am currently a pet Mom to rescued dogs, cats, rabbits, chickens, turkeys, and goats...you can't say I didn't listen to what my mother told me!

My goal as the President of the Board of Directors is to help the organization move in a direction that will allow us to continue to help the stray and abandoned animals of Southern Nevada. As an organization, we must continually grow in order to meet the needs of the animals we are devoted to helping. It is my desire to help facilitate that growth. I am excited to continue to work with our volunteers, supporters, and members as well as meet many more of you.

The ways in which Karen has lent her expertise and experience in order to better the lives of the homeless animals of Clark County are countless. She is very involved with reducing the number of feral cats in the valley through TNR (trap-neuter-release) efforts, feeding feral cat colonies, and spay and neuter clinics. Karen advocates for these cats, which don't have many looking out for their well-being, by becoming involved in efforts to pass the free roaming cat ordinances and mandatory spay/neuter legislation. On the topic of legislation, Karen has spoken out at many commission meetings on behalf of efforts to reduce and eliminate the use of leg hold traps for wildlife. Another area close to Karen's heart is reaching into communities with the greatest need to help them with responsible pet ownership. This is evident in her helping to plan community outreach events where LVVHS has worked with Heaven Can Wait Animal Society and local veterinarians and volunteers to bring services such as vaccine and microchip clinics and spay/neuter appointment arrangements right into communities of need. As a foster Mom to cats from newborn bottle babies to senior cats that suddenly find themselves without a home, Karen has helped in this capacity over the years as well.

He was taken to our veterinarian for an examination where it was discovered that he is deaf, has cataracts in both eyes, and a mouth full of rotten teeth. Poor Al B.'s hair was matted to his skin. He is a sweet boy who is good with other dogs. He would do best with another dog or person who can be home with him. Al B. is neutered, current on vaccinations, has had dental and teeth extractions done, and is micro-chipped.

**Cinnamon** is a 13+ year old DSH Torbie who was found as a stray on the side of Interstate 15 near Hwy 169. She was turned over to LVVHS when no owner claimed her. She was skin and bones when we got her so our veterinarian recommended lab tests. The results came back and it was recommended that she be fed Hills Prescription k/d only. She is the sweetest girl who loves everyone she meets and deserves a forever home. Cinnamon is spayed, current on vaccinations, Felv/FIV tested negative, and is micro-chipped.



#### **RESCUE ROUNDUP: A FEW OF THE MANY!**



STRAY CAT WITH AN INJURED TAIL! - LVVHS received a call about a stray cat that had been hanging around a neighborhood for quite some time. A resident became concerned when the cat came to his front door with an injury to her tail. The tail appeared to be broken and she had an open wound that was bleeding. A LVVHS volunteer went to her rescue and rushed her to Sunrise Veterinary Clinic. It was determined that the tail needed to be amputated. Maya was placed in a foster home after surgery to recover. She was also spayed, vaccinated, FELV/FIV tested negative, and micro-chipped. Maya has since recovered and was adopted to a wonderful new home.

PARVO SURVIVOR! - Your donations throughout the year help LVVHS save lives when emergencies happen and an animal must be rushed to the hospital for treatment. Wilson was rescued from the streets and after a day in his foster home, he started to vomit and have diarrhea. He was seen by our veterinarian and tested positive for parvo. He was so sick, he had to be hospitalized at the Veterinarian Emergency Critical Care Center. It was touch and go for a while, but Wilson pulled through and is a healthy, happy boy! We are so thankful we had the money available, thanks to our donors, to get Wilson the treatment he needed.
